Payments: The cost of Rosapepe Retreats tour (Salerno-Contursi-Cilento Coast) is \$4750.00 USD per person. A \$500.00 per person deposit check will be needed in order to hold your space on the trip. Single Supplement Available – See terms below.

This document outlines what Rosapepe Retreats, LLC ("RR") agrees to provide when you register for a RR tour, and what you agree to do in return. This information is very important, please read it carefully and sign below.

Current tour prices are listed on the reservation page for the tour. Due to currencies fluctuation and other factors beyond our control, tour prices may change without notice at any time. Price changes are not retroactive, and tour participants who already registered for a tour will not be affected by any price changes.

Included in the price of the tour:

- accommodations at the Rosapepe Family hotel in the countryside of Contursi in the region of Campania. RR reserves the right to substitute accommodations of similar standard when necessary. Additional hotel accommodations as noted on said itinerary may also be included, depending on tour chosen.
- all transportation during included group activities as per itinerary: transportation will be in vans or small buses.

-please note that transportation vehicles have no handicap provisions at this time. Hotel has limited handicap access per Italian law/requirements.

- one time each way group transfers between the station and the hotel on arrival and between the hotel and the station on departure on selected tour. Transfers for individual early arrivals and late departures or different arrival/departure points other than directed by RR are not included.

- all meals as per itinerary: breakfast at the hotel, dinner and/or lunch at either the hotel restaurant or at a restaurant or tour site as per itinerary. ONE drink with lunch and dinner, alcoholic or non-alcoholic;

- all included group activities and side excursions, as per itinerary.

- all sightseeing, fees, and admissions, as per itinerary.

- full time RR tour escort, professional in-country guides, bi-lingual (English and Italian) local guides in selected attractions.

All quoted prices include the cost of the tour operator planning and operation. Tour prices DO NOT INCLUDE: airfares and airport taxes (unless otherwise noted), local hotel tax daily use charge, other transportation to tour location, laundry charges, telephone calls, room service charges, mini-bar charges, all items of personal nature, travel, accident, baggage, health, or life insurance, tips for guides and drivers unless stated otherwise, private excursions, recreational activities not mentioned in the itinerary, optional activities, passport and/or visa when applicable. There will be free time during the tour week. RR is not responsible for fees associated with any transportation to and from hotel for a participant's individual activity. Smokers may smoke only outdoors and downwind from the group - never in hotel rooms or during group meals or activities. Smokers will stay in a single room, unless they share a room with another smoker.

Travel insurance is not included in the tour price. Travel documents and visas: Tour Participants are required to have a valid passport and a visa, if necessary. If a tour is cancelled due to low enrollment, you will be notified at least 60 days in advance. In this case, your entire payment will be refunded to you within fourteen days after the tour cancellation, as required by the state of Maryland. Refund of payments made constitutes full settlement, and releases RR, LLC from any further liability. RR is not responsible for any additional expenses incurred by tour members preparing for a canceled tour, such as nonrefundable airline tickets or passport fees. In the unlikely event of a tour cancellation, you will receive a \$100 gift certificate valid towards another tour within 18 months of the tour cancellation. If a tour is cancelled due to a natural disaster, strike, or other event outside our control, we cannot guarantee the 60 days' notice, but you will receive a full refund of all payments made.

RR strongly encourages all Tour Participants to purchase Travel Insurance to cover additional costs (airline tickets, loss of luggage, trip delay or tour cancellation, personal accident, medical evacuation, etc.).
